#### **ORDINANCE NO. 20-04**

## AN ORDINANCE AUTHORIZING THE TRANSFER OF AND AMONG CERTAIN APPROPRIATIONS IN PART FOR THE FISCAL YEAR 2020

WHEREAS, the Village of Forest View is a home rule unit of local government pursuant to the provisions of Article VII, Section 6 of the Illinois Constitution of 1970; and

WHEREAS, as a home rule unit of local government, the Village may exercise any power and perform any function pertaining to its government except as limited by Article VII, Section 6; and

WHEREAS, the transfer of and among certain appropriations made and approved in Ordinance 19-11 entitled "An Ordinance Making Appropriations for General Corporate and for Special Purposes for the Village of Forest View, Cook County, Illinois for the fiscal year beginning May 1, 2019 and ending April 30, 2020; and

WHEREAS, the President and Board of Trustees have considered said recommendation and desire to make such transfers in the manner provided by statute;

NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW, COOK COUNTY, ILLINOIS IN THE EXERCISE OF THE VILLAGE'S HOME RULE POWERS, as follows:

**SECTION 1:** That Ordinance 19-11, entitled "An Ordinance Making Appropriations for General Corporate and for Special Purposes for the Village of Forest

View, Cook County, Illinois for the Fiscal Year beginning May 1, 2019 and ending April 30, 2020 is hereby amended to read as follows.

SECTION 2: That the following sums of money be and the same are hereby transferred in accordance with the provisions of Section 8-2-9 of the Illinois Municipal Code;

SECTION 3: This Ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the Village of Forest View that to the extent that the terms of this ordinance should be inconsistent with any non-preemptive state law, that this ordinance shall supersede state law in that regard within its jurisdiction.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage and approval and publication in pamphlet form as provided by law.
