# FROM THE VILLAGE OFFICE...

## APPLICATIONS AVAILABLE IN THE VILLAGE HALL

### ANNUAL DOG LICENSE



We would like to take this opportunity to remind all residents that per Village Ordinance **all dogs must be registered annually** with the Village Office and wear an up-to-date dog identification tag. The annual fee of the dog license/identification tag is \$1.00. To obtain a license, owners must show proof of a current rabies vaccination. No more than three (3) dogs are allowed per residence.

To make it both ***easier to remember*** and ***more convenient***, dog licenses and vehicle stickers are being sold the month of June.

**So, no matter when you registered/purchased your dog license/tag in calendar year 2023, you are required to purchase a 2024-2025 tag by June 30, 2024.**

If you haven't purchased a current 2024-2025 dog license, please be sure to stop by the Village Office soon! Failure to purchase a dog license in June each year will result in a \$50.00 citation per dog for being in violation of Village Code.



### VEHICLE STICKERS

All vehicle stickers for 2024-2025 are **due on June 30, 2024** and are to be displayed on your windshield no later than July 1, 2024.

The vehicle sticker price for a passenger car is \$10.00; senior citizens 65 and older the fee is \$2.00 (one per household). Stickers purchased after due date, an increasing monthly late penalty will be imposed. Vehicles not displaying a current village sticker as of July 1<sup>st</sup> are also subject to enforcement action. Stickers may be purchased at the Village Office Monday thru Friday during the hours of 9:00 a.m. to 5:00 p.m.

If during the year you purchase another vehicle, please remember to stop by the Village Office to transfer or purchase a sticker, whichever the case might be.



The Drop Box is available for water bill payments, police ticket fines, and other Village business, located by the back entrance (parking lot side) of the Village Hall. **Please do not put cash in the outside box. Payments dropped in the box must be by check.**

## FROM THE VILLAGE OFFICE...

### BUILDING PERMITS

**You will be fined \$100.00 plus double the cost of the Building Permit if you start work without obtaining a Building Permit. NO EXCEPTIONS.**

**A building permit must be obtained prior to the construction, alteration/remodel or repair of any house/property whether doing the work yourself or by a contractor.** Permits are needed for, but not limited to, the following: alterations involving moving or adding walls, basement finish-out, electrical and plumbing work, HVAC work, shed, fence, deck, patio, roof, driveway, window replacement, siding, solar panels, swimming pool. **If you're not sure if a permit is required, please call the Village Office at 708-788-3429.** Some building permits require a fee, however many projects there is no fee at all for the permit.

Permits are required to ensure that the work adheres to Forest View Building Codes. Also permits can guarantee that a contractor is insured and bonded and the homeowner is protected from fraud.

### Before You Dig, Call (or Click) JULIE

If you are planning an outdoor project, call JULIE before you dig to avoid injury and/or damage to underground utilities. Simply call 811 or 1/800/892-0123. The call is free and so are the services. ### GARAGE SALES

Spring/summer cleaning in many cases means garage sales. Just as a reminder, sales are limited to two (2) per household per year. There is no fee to hold a sale, but a permit is required. Permits should be obtained at the Village Office three (3) days prior to the planned sale. Sale hours are limited between the hours of 9:00 a.m. and 5:00 p.m. and sales cannot last more than three (3) consecutive days. Regular items found around the house are allowable in garage sales; however, arts and craft items are not. All advertisements must be removed from the parkway within 24 hours of the completion of the sale, and **at no time are signs to be placed on street light poles, stop signs or parking signs.**

**Safe Haven Baby Drop Off**

The Village of Forest View is a Safe Haven Baby Drop Off Location. We have two signs posted, by the Fire Department.

There is nothing more tragic than hearing a story about a baby being found abandoned in a dumpster. Feelings of desperation and hopelessness lead mothers to take a step so drastic. They feel alone and helpless. It is critical for any woman who finds herself in this frame of mind to know that there is a safe alternative: Safe Haven Baby Drop Off.

Safe Haven laws allow a mother to surrender her baby anonymously at designated locations. The mother can surrender her baby safely without having to worry about being prosecuted for abandonment. These laws have been enacted in all 50 states.



The Village Hall parking lot / back door is a MEETUP SPOT for internet purchases. The area is under 24-hour surveillance.

**The Village's Noise Ordinance 24-06**, is in effect between the hours of nine-thirty (9:30) P.M. and eight o'clock (8:00) A.M. Sunday through Thursday and ten-thirty (10:30) P.M. and eight o'clock (8:00) A.M. on Friday and Saturday.

Please be aware of the times listed above and respect your neighbors by following the noise ordinance.

Construction and Landscaping should take place between the hours of 8:00 A.M. through 8:00 P.M.

**The Village's Short-Term Rental Ordinance 24-07**, is in effect.

**SHORT TERM RENTALS PROHIBITED**

3-25-1 - SHORT-TERM RENTAL: A single-family dwelling, or a residential dwelling unit in a multi-unit structure, condominium, cooperative, timeshare or similar joint property ownership arrangement that is rented for a fee for less than 30 consecutive days. "Short-term rental" includes vacation rentals.

**SHORT-TERM RENTALS PROHIBITED**

- (A) - Short-Term Rentals are prohibited in the Village of Forest View.
- (B) - The prohibition on short-term rental units shall not apply when the immediately preceding owner of a property maintains possession of the dwelling unit after closing on a real estate transaction for the sale thereof and leases said property back from the successor owner for a period of time pursuant to a written agreement.





## Fire Department Summer Safety Tips

Did you know that almost 30% of all grill fires will occur during June and July? Did you know that during the Fourth of July thousands of people will visit the emergency room due to injuries received while using consumer fireworks? Summer is here, and with the Fourth just around the corner, families and friends are getting “fired up” for summer with BBQs, campfires and other fun seasonal outdoor activities. While these are all great ways to bring folks together, safety needs to remain the number one priority.

Whether it be barbequing, enjoying fireworks, cooking s’mores or using candles to keep the bugs away, here are the top five summer fire safety tips to enjoy a safe and fun summer.

1. **Grill safely:** Always use your grill outdoors, keeping it away from siding and deck railing. For gas grills, check the gas supply line for damages and replace it, if needed. If you are using charcoal, use an electric or chimney lighter that allows you to use newspaper rather than lighter fuel. Always wait until your grill cools completely before putting it away, especially if you use a grill cover.
2. **Leave fireworks to the pros:** When it comes to fireworks, you are literally playing with fire – and in many states, you may even be breaking the law. The best choice is to pack a picnic basket and catch some of the amazing fireworks displays hosted by professionals in your community. Or, enjoy professional fireworks from the comfort of your own home, such as Macy’s July 4<sup>th</sup> Fireworks, which will air on NBC on July 4th at 7:00 p.m. If you do choose to enjoy consumer fireworks, make sure they are legal in your area. Dress smart – no bare skin or loose clothing if you are near fireworks. Always use fireworks away from buildings, overhead branches or trees, dry grass, or combustible fuels. Keep a water hose or fire extinguisher in reach and know how to use it.
3. **Be careful with outdoor fireplaces and candles:** Make sure that there are no structures, low tree branches or other flammable overhead obstructions near your tiki torch, candle or campfire. Keep fires small, away from dry grass and leaves, and at least 10 feet away from anything else that can burn.
4. **Always keep kids and pets away from fire:** Keep kids and pets away from campfires, fireworks, candles, matches and lighters. Avoid playing games with flying objects like baseballs, basketballs or plastic discs anywhere around the grill, torches or candles.
5. **Never leave any flame or fire unattended:** Whether you’re grilling, using a fire pit, or toasting s’mores around the fire, never leave any flame or fire unattended and put out any fire before you leave it.

## 4<sup>th</sup> of JULY

**This Community Notification is being given to all residents of Forest View as a means of communicating the law concerning the possession and discharge of fireworks within the Village and the actions and enforcement you will be seeing over the 4<sup>th</sup> of July Holiday.**

For the Safety and Wellbeing of our residents, the Forest View Police Department will be enforcing state and local fireworks ordinances.

The Illinois Pyrotechnic Use Act (PUA) bans the sale, possession and use of all consumer fireworks that can be bought illegally in some states such as firecrackers, bottle rockets and roman candles. Possessing, selling and using consumer fireworks may be punishable by a fine.

Novelty fireworks, such as sparklers, snakes, party poppers and caps are not regulated but are available for retail purchase in Illinois. Young children should be supervised when using sparklers, which can reach temperatures of up to 1800 degrees Fahrenheit. The sparkler wire also presents a serious danger because of the high temperature of the wire during and after use.

Forest View residents can call 911 or the non-emergency police number at **708-788-0318** (use your best judgement) to report excessive use of illegal consumer fireworks.

Our goal is to keep fireworks out of the hands of children, reduce the number of fireworks-related injuries and fires, and curtail the illegal possession and discharge of fireworks.

Remember to make sure that your house is secure and that either your mail is stopped, or that someone can collect your mail until your return, and make arrangements to have your lawn cut. Also, put your house lights on timers, and have neighbors keep an eye on your house. Another safety precaution, do not post travel plans on Facebook or post vacation pictures while away. **Please inform the police department when you are leaving and returning and we will do physical checks of your home. Or, if you prefer, we can just do drive-by surveillance. Please stop by the police department to let us know your preference.**

## **PUBLIC WORKS**

### **LAWN MAINTENANCE**



Homeowners can help keep our community neat and attractive and reduce harborage areas for unwanted rodents by regularly mowing their lawns. **Please Note:** We perform weekly blight checks.

### **PLEASE ADVISE YOUR LANDSCAPER**

Please advise your landscaper..... **DO NOT** rake or blow your leaves or grass clippings into the street. When it rains, this clogs up the sewer inlets and flooding can result. Therefore, please advise your landscaper to place leaves in a **PAPER** yard waste bag or garbage can with a Compost Sticker affixed to the can. (stickers are available at the Village Hall free of charge)

### **PARKWAY TREES**

Parkway trees are village owned, Therefore, property owners are prohibited from trimming their trees. Please contact Public Works if you have any concerns with your tree. Our contact number is 708-788-3429.

### **WENONAH SEWER PROJECT**

We have officially broken ground! Although most of the work will be done on Forest View Terminal Drive, there will be some work done on the dead end of Wenonah to make the connection that will run under the railroad. This project should help alleviate our sewer system during heavy rainfall, especially on the dead end of Wenonah which is the lowest point in town.

### **GARBAGE PICK-UP**

**GROOT** will only pick up glass if it is taped or placed between two pieces of cardboard.

Tires and electronics will not be picked up by the garbage /recycling collectors or by the Village.

Branches and bushes should be bundled into piles no thicker than 2 feet, no longer than 4 feet and not exceeding 45#.

### **HYDRANT FLUSHING**

Public works will be flushing all fire hydrants once this summer and again in fall. This helps prevent rusty colored water that can build up in the water main leg that feeds each hydrant. Signs will be posted around town on the days we are flushing. During the flushing you may experience slight loss of water pressure, cloudy/milky water(turbidity), or orange/red colored water. If you experience any of those, please allow your water to run for a few minutes and check the screens on faucets. If you are still experiencing issues, please call the Village office and ask for the Water Dept.

Dear Forest View Residents,

With the summer months upon us, please keep in mind the rodent problems that persist in surrounding communities, and prevent rodent problems from occurring in our village. The information provided below is meant to bring awareness of the possible conditions ideal for rodents and what we can do as a community to help prevent this.

- **Excess pet waste:** Dog waste is an environmental pollutant. In 1991, it was labeled by the Environmental Protection Agency (EPA), placing it in the same category as herbicides and insecticides; oil, grease, toxic chemicals; and acid drainage from abandoned mines.
- Dog waste does not make for a good fertilizer. It is toxic to your lawn, and it has been estimated that a single gram of dog waste can contain 23 million fecal coliform bacteria. Dog poop attracts rats and mice. Inside the excrement there are usually bits of food that can be a valuable resource to rodents.
- **Tall grass:** An un-mowed back yard provides shelter and concealment for rodents.
- **Bird feeders/animal feed:** If you own or use bird feeders it is important to routinely clean feeders so they do not attract unwanted animals.
- **Sheds:** If you have a shed on your property, it is vital that you do not leave old lawn clippings sitting on your shed floor. Rats will also be attracted to sheds that do not sit on concrete, if the shed is sitting on a wooden foundation, the foundation will eventually rot and become a haven for rats to burrow under.
- **Trash Bins:** Making sure that your trash receptacles are properly stored and sealed will help deter rats. Avoid throwing loose garbage in trash bins. It is better to throw household waste in a plastic /paper bag and tie shut before placing in your trash bin.

**Who to call for help:** If you have seen rats around your property, please call **Stickney Animal Control**. They will be able to provide you with trap boxes free of charge that will be placed around your property. You can contact them at (708) 237- 8923 Monday thru Friday 8:30 am to 4:00 pm. Feel free to stop in the Village Hall and pick up a brochure from Stickney Township for more information.

The cycle begins and ends with you! Don't let Rover's relief become your neighbors' nuisance. Always bag it and trash it, even when no one is looking!

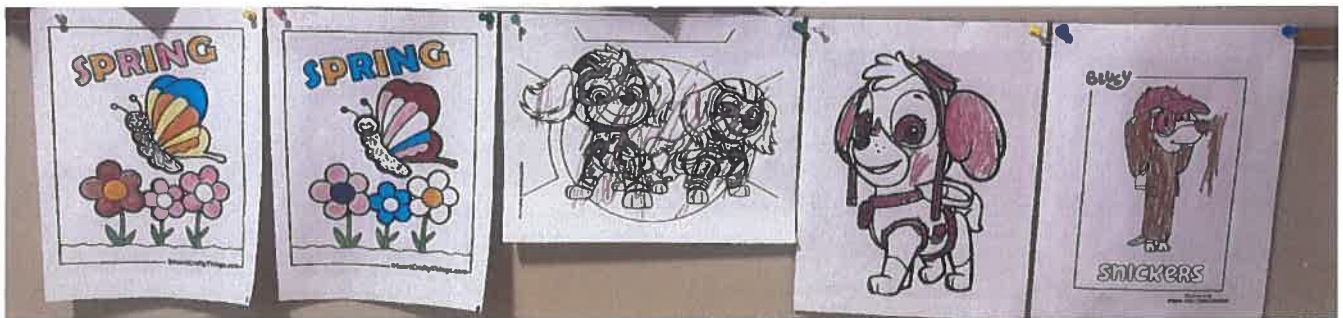

## BOARD BRIEFS

**\*\* The Board meets in the Municipal Building on the second and fourth Tuesday of the month and the meetings begin at 7:00 P.M and are open to the public.\*\***

### February 27, 2024

Maria Guzman was sworn in as a Full Time Police Officer and Police Officer Jorge Sanchez was sworn in as a Corporal by Village Clerk McGuffey. Family, friends and residents were present to take photos and to congratulate them.

Superintendent of Water and Public Works Filec is requesting Board approval to finalize and approve the bid for \$1,962,675.00 from M and Q Construction Company, for the work to be performed on the Wenonah Avenue sewer project.

Superintendent of Water and Public Works Filec is requesting Board approval to obtain bids for the Village of Forest View's street resurfacing project.

Village Administrator Dropka addressed requests by Village Trustees to further discuss the purchase of speed bumps and speed humps.

Centennial Planning Committee Chairperson Laura D. McGuffey mentioned the Committee is working hard organizing all the photos and newspaper clippings going back from 1950.

Trustee Grossi spoke about when he first moved into the village 30 years ago. He was visited by a Village Trustee who came to his house to welcome him and his family. Trustee Grossi mentioned that he would like to bring this welcome visit back to the Village again.

### March 12, 2024

Superintendent of Water and Public Works Filec is requesting Board approval to enter into a three (3) year contract with Standard Equipment through tax exempt Leasing Corp. to lease-purchase a 2024 Elgin Pelican NP Street Sweeper with an annual payment of \$117,405.95 to start in March of 2025.

Village Administrator Dropka continues to work on the Special Service Area tax to put in place for the businesses around Central and 47<sup>th</sup> Street, and the voluntary annexation application from a business on the corner of 51<sup>st</sup> Street and Central.

Sergeant Perez mentioned that the police department is able to print out tickets online from their vehicles now, using the Quicket system.

### March 26, 2024

Village Administrator Dropka is requesting board approval for Ordinance # 24-02, amending Section 9-2-3 of the Village Code to prohibit the parking of motor vehicles on unpaved surfaces.

Superintendent of Water and Public Works Filec is requesting board approval to move forward with M & J Asphalt Paving Company Inc. to perform the work for the 2024 Forest View resurfacing project.

Fire Chief Jones mentioned that businesses have been inspected and they will be following up with some violations.



Police Chief Zarate reported that the new speed signs have been installed, his department will start enforcing the new Ordinance and will be writing higher fines when speeding in School and Park Zones.

Trustee Grossi is creating a new Vehicle Sticker for our 100<sup>th</sup> Year Anniversary.

President Miller mentioned that PAV YMCA is having a Healthy Kids Day on April 20, 2024. She stated that they would like to get Forest View more involved with the YMCA and mentioned that they are asking for sponsorships. The board agreed that they would donate \$500.00 as long as our residents who participate in the YMCA programs, are charged the resident rate.

#### **April 9, 2024**

Village Administrator Dropka is requesting board approval regarding Ordinance No. 24-04, amending section 4-1-7 of the Forest View Village Code, regulating the number of kitchens in single family residences.

Superintendent of Water and Public Works Filec announced that the Village of Forest View was officially a member of Tree City USA.

Police Chief Zarate commented that April is Autism Awareness Month. His department will be wearing the new multi-colored patches on their police uniforms.

Fire Chief Jones reported that Cinder is getting big and is doing good. She will have her second day of obedience training tomorrow. She loves meeting residents during her walks in the Village.

#### **April 23, 2024**

President Miller is proclaiming May 18<sup>th</sup> through May 24<sup>th</sup> this year 2024, as National Safe Boating Week in the Village of Forest View, Illinois, and urges all residents to

always practice safe boating techniques while on our lakes and waterways.

President Miller is proclaiming the Month of May, this year 2024 as Motorcycle Awareness Month, urging motorists to join in improving safety and awareness on our roadways.

Superintendent of Water and Public Works Filec is requesting board approval to recognize Friday, April 26, 2024 as Forest View's 2024 Arbor Day; and approve the Tree City USA proclamation.

Village Administrator Dropka reported that he is working on a False Alarm Ordinance to address the unnecessary number of false alarms that are occurring at commercial properties due to faulty alarm systems.

Village Administrator Dropka reported that he is working on an ordinance that increases the penalties for Class D liquor license violations.

Police Chief Zarate reported that he would like to restart a program where his Police Officers will be carrying vouchers to hand out to kids when they see them doing something nice in the village. The kids will be able to cash them in at the Shell Gas Station for ice cream.









Village Administrator Dropka mentioned that they are 99% done with the phasing stage for the berm and are waiting on the easements.

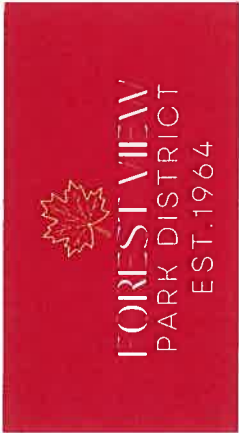

### **What does a Park Commissioner do?**

All candidates should have a genuine interest in both park/playground improvements and passive recreation.
