AN ORDINANCE AMENDING TITLE 9 OF THE FOREST VIEW VILLAGE CODE

BE IT ORDAINED by the President and Board of Trustees of the Village of Forest View, Illinois as follows:

SECTION 1: Amendment. Section 9-3-1 of the Forest View Village Code, "Speed Restrictions," is hereby repealed in its entirety and replaced with the following:

9-3-1: SPEED RESTRICTIONS:

- (A) The speed limit for motor vehicles in the Village shall be 20 miles per hour with the exception of Harlem Avenue.
- (B) Speeding While Passing Schools. For the purpose of this Section, "school" means the following entities:
 - (1) A public or private primary or secondary school.
 - (2) A primary or secondary school operated by a religious institution.
 - (3) A public, private, or religious nursery school.

"School Zone" means eastbound 45th Street between Harlem Avenue on the west and Oak Park Avenue on the east.

No person shall drive a motor vehicle at a speed in excess of 20 miles per hour in a School Zone on a school day. For purposes of this Section, the school day begins at 6:30 a.m. and concludes at 4:00 p.m.

(C) Speeding Near a Public Park. Any person who drives a motor vehicle at a speed in excess of 20 miles per hour on 46th Street, between Grove on

the east and Maple on the west is guilty of speeding in the vicinity of a public park.

(D) Aggravated Speeding In the Vicinity of a Public Park. Any person who drives a motor vehicle at a speed in excess of 26 miles per hour on 46th Street between Grove on the east and Maple on the west is guilty of aggravated speeding in the vicinity of a public park.

(E) Penalties. A violation of Subsection A of this Ordinance is punishable by a minimum fine of two hundred fifty 00/100 (\$250.00) dollars. A violation of Subsection B or C of this Ordinance is punishable by a minimum fine of two hundred fifty & 00/100 (\$250.00) dollars. A violation of Subsection D of this Ordinance is punishable by a minimum fine of five hundred & 00/100 (\$500.00) dollars.

SECTION 2: Signage. The Village Administrator is hereby authorized and directed to post appropriate warning signs giving proper warning notice of the fines authorized by Subsections B and C.

SECTION 3: Section Repealed. Section 9-3-3 of the Forest View Village Code, "Additional Traffic Control Signs," is hereby repealed.

SECTION 4: Section Repealed. Section 9-3-5 of the Forest View Village Code, "One-Way Streets," is hereby repealed.

SECTION 5: Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.
